REVIEW PROCESS

Each Application is individual, for only one hotel property. No group or chain Application is accepted.

Classic Travel Service, Inc. reviews each Application carefully. However, it is Hotel's responsibility to provide us with all documents and access to your high-resolution photography library, required to complete the Application review.

No complimentary stay in Hotel is required or accepted by Classic Travel Service, Inc. prior to selection. Prior to our decision on the property's selection for Classic Travel's website, any stay at your property by a correspondent or an employee of Classic Travel Service, Inc. will be anonymous and paying.

Classic Travel Service, Inc. will advise Hotel of its selection decision within two (2) weeks of Hotel's Application. We, at Classic Travel Service, Inc. value uniqueness and personality as important criteria for selection. However, We make our selection based on sole discretion. Classic Travel's decision cannot be negotiated or contested.
